3. that their nomination can be terminated before the expiry of term without assigning any reasons or giving any notice.

Further , the facilities of AMA's in respect of CSIR Complex employees , Pusa, New Delhi and their family members can be withdrawn at later date if the area of their residence is found to be covered under CGHS Scheme or family of Govt. doctors is available in any system of medicine within a radius of 5 km of residence as per rules.
