

In continuation of CSIR HRDG OM of even number dated 10th Feb 2023, it is brought to kind notice of all concerned that revised guidelines referred at (i) above are effective from 1st March 2023 except the clause of CONTINGENCY. Contingency in reimbursement mode is applicable to prior cases also as per procedure mentioned under REVISED guidelines. In addition to other clauses mentioned under revised guidelines, upgradation/continuation/extension etc. of CSIR fellows whose date of assessment is after 1st March 2023 will be dealt as per provision in revised Guidelines.

सीएसआईआर एचआरडीजी समसंख्यक कार्यालय ज्ञापन दिनांक 10 फरवरी, 2023 के अनुक्रम में यह ध्यान में लाया जाता है कि ऊपर उल्लिखित संशोधित दिशानिर्देश आकस्मिकता के खंड को छोड़कर 1 मार्च 2023 से प्रभावी हैं। आकस्मिकता प्रतिपूर्ति के नए दिशा-निर्देशों के तहत प्रक्रिया के अनुसार पूर्व मामलों पर भी लागू होती है। संशोधित दिशा-निर्देशों के अंतर्गत उल्लिखित अन्य खंडों के अतिरिक्त, उन्नयन/निरंतरता/विस्तार आदि 1 मार्च, 2023 से नए दिशा-निर्देशों के प्रावधानों के अनुसार किया जाएगा।

Further, old guidelines referred at (ii) above are effective up to 28th Feb 2023 except Contingency. Contingency in reimbursement mode is applicable to prior cases also as per procedure mentioned under REVISED guidelines. In addition to other clauses mentioned under old guidelines, up gradation/continuation/extension etc. of CSIR fellows (whose date of assessment is upto 28th Feb 2023) will be dealt as per provision mentioned in old Guidelines.

It is also mentioned here that the clauses pertaining to receipt of re-imbursement of annual contingency grant and medical facility will also be applicable to fellows availing CSIR's JRF-NET, JRF-GATE, SPMF, SRF-DIRECT, RA and other fellowships.

Subject to condition that

"tenure of the JRF may be continued further for six months on the condition that an undertaking by the concerned institution assuring that they would conduct the three-member assessment committee and submit the report in the next six months"

"In case assessment report is not received till the end of the third year, the fellowship shall stand terminated without further notice.

- Fellows and host institutions are strongly advised to complete the Assessment and submit the report timely to avoid delays.
- Nonetheless, to minimize the hardship to students, fellows are given six months from the time of completion of the second year of JRF to submit the Assessment Evaluation Report.
- During this period (six months) he/she shall be getting fellowship of JRF, subject to submission of online attendance certification by Host Institute on the portal as usual procedure for fellowship.

 Noncompliance of CSIR norms for submission of annual progress report along with other requisite documents within six months after completion of yearly tenure will be resulted in termination of fellowship/associateship

The 5th year extension as SRF(NET) is permissible on the recommendation of a three member assessment Committee and progress report duly supported by publications in the form of reprints/preprints/manuscripts of the paper published, accepted or communicated for publication

- The annual progress report for continuation from third to fourth and from fourth to fifth year is to be maintained by the Host Institute.
